Consumer Legal Action Fund

The Fund was set up on 30 Nov 1994. The Fund has altogether considered 26 groups of cases. Each group ranges from several to thousands of consumers. Further, the Fund is presently considering whether legal assistance should be granted to 1 group of cases. The Fund has received applications from 1 group of cases. As consumers should exhaust all other means of dispute resolution before the Fund would consider their applications, the 1 group is now handled by the Council (Complaints and Advice Division) and would be referred to the Fund for consideration if necessary.
